Additionally, Mr. Gray funded a billboard advertisement to market his firm, which he also believes serves as inspiration for young African American youth to pursue careers in law by showcasing a young black face dressed in a professional manner.

Mr. Gray graduated from North Carolina State University in 2014 with a Bachelor of Science in Sports Management. He subsequently received a Doctor of Jurisprudence at North Carolina Central University School of Law in 2017. While pursuing his undergraduate degree, Mr. Gray completed several internships between 2012 and 2015 in sports and legal affairs. He remains a member of the Phi Sigma Pi National Honor Fraternity.

Attributing his personality and legal background to much of his success in law, Mr. Gray believes he possesses the ideal disposition for his profession. He is also capable of developing strong relations with his clients and instilling in them a sense of confidence in his abilities to fight the law and win.

Despite his own success, Mr. Gray attributes a great deal of his current status to the many lawyers in his family, particularly his parents, for providing him with an invaluable legal foundation.
